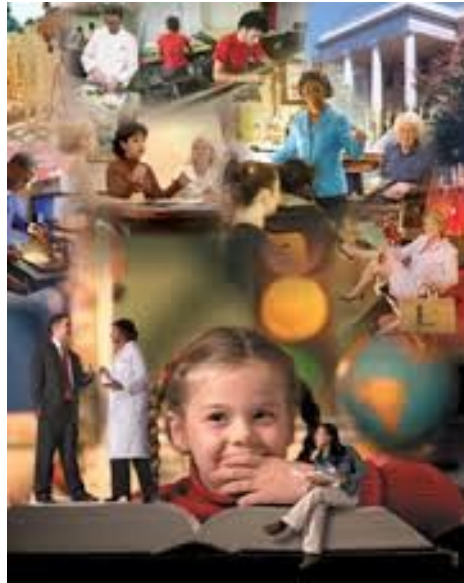

History

Generous donations from past state and district presidents of the California Association of Family and Consumer Sciences (formerly known as the California Home Economics Association) provided the initial \$10,000 allotment for the Extended Education Fund, commonly known as the Grants and Scholarships Fund. Over the years, the Fund has increased due to the continued donations from members of our profession and careful investments of the funds.

Purpose

The primary purpose of EEF is to provide student scholarships and grants.

- ◆ \$1,500 scholarships are available yearly for an FCCLA high school senior, an FCS student teacher and several California undergraduate and graduate students of FCS programs in community colleges and universities.
- ◆ Grants support innovative projects critical to the advancement of CA-AFCS and/or priority issues relating to research, public awareness and growth of the profession. Proposals can be funded up to \$2,000 for projects to be completed in two years. Also professional development grants are available for new officers of the association.



Donations

Contributions to the Grants and Scholarship Fund enable our professionals to be on the cutting edge and engage in activities that are relevant and responsive to various California initiatives and community needs.

Contributions are usually tax deductible. They can be made periodically throughout the year or as a one time sum at any point in the year. In addition, designated estate gifts are accepted. It is now possible to provide donations from IRAs through *The Protecting Americans Against Tax Hikes Act of 2015*. Consultation with a trusted tax advisor is recommended.
